

Privacy Policy

Protecting your private information is our priority. This Privacy Policy applies to Logan Security Consulting LLC and the Hidden Camera Detector app and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Logan Security Consulting LLC (“LSC LLC”) include the Hidden Camera Detector app (“HCD App”). The HCD App can at your option include location information on captured images. By using the HCD App, you consent to the data practices described in this statement.

Collection of Your Personal Information

LSC LLC may collect personally identifiable information. LSC LLC will collect anonymous demographic information, which is not unique to you, such as your age, gender and location. We may gather additional personal or non-personal information in the future.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through your use of the HCD App, this information may be collected and used by others.

Use of Your Personal Information

LSC LLC collects and uses your personal information to operate its app.

LSC LLC may also use your personally identifiable information to inform you of other products or services available from LSC LLC and its affiliates. LSC LLC may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

LSC LLC does not sell, rent or lease its user lists to third parties.

LSC LLC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, facebook information) is not transferred to the third party. LSC LLC may share data with trusted partners to help perform statistical analysis and provide user support. All such third parties are prohibited from using your personal information except to provide these services to LSC LLC, and they are required to maintain the confidentiality of your information.

LSC LLC will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with any legal process served on LSC LLC; (b) protect and defend the rights or property of LSC LLC ; and, (c) act under exigent circumstances to protect the personal safety of users of LSC LLC , or the public.

Security of your Personal Information

LSC LLC secures your personal information from unauthorized access, use or disclosure.

Legal Basis for Processing Personal Data Under General Data Protection Regulation (GDPR)

If you are from the European Economic Area (EEA), LSC LLC's legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Data we collect and the specific context in which we collect it.

LSC LLC may process your Personal Data because: We need to perform a contract with you; You have given us permission to do so; The processing is in our legitimate interests and is not overridden by your rights; For payment processing purposes; and To comply with the law.

Retention of Data

LSC LLC will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. LSC LLC will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

Transfer of Data

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

If you are located outside the United States and choose to provide information to us, please note that we transfer the data, including Personal Data, to United States and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

LSC LLC will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to any third-party organization or a country unless there are adequate controls in place including the security of your data and other personal information.

Disclosure of Data

Business Transaction

If LSC LLC is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy.

Disclosure to Law Enforcement

Under certain circumstances, LSC LLC may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

Legal Requirements

LSC LLC may disclose your Personal Data in the good faith belief that such action is necessary to:^[1]_[SEP] To comply with a legal obligation; To protect and defend the rights or property of LSC LLC; To prevent or investigate possible wrongdoing in connection with the Service; To protect the personal safety of Users of the Service or the public; and To protect against legal liability.

Security of Data

The security of your data is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

Your Data Protection Rights Under the General Data Protection Regulation (“GDPR”)

If you are a resident of the European Economic Area (“EEA”), you have certain data protection rights. LSC LLC aims to take reasonable steps to allow you to correct, amend, delete, or limit the use of your Personal Data.

If you wish to be informed what Personal Data we hold about you and if you want it to be removed from our systems, please contact us directly. In certain circumstances, you have the data protection rights to access, update or to delete the information we have on you. Whenever made possible, you can access, update or request deletion of your Personal Data directly within your account settings section. If you are unable to perform these actions yourself, please contact us to assist you.

You have the following data protection rights:

The right of rectification. You have the right to have your information rectified if that information is inaccurate or incomplete.

The right to object. You have the right to object to our processing of your Personal Data.

The right of restriction. You have the right to request that we restrict the processing of your personal information.

The right to data portability. You have the right to be provided with a copy of the information we have on you in a structured, machine-readable and commonly used format.

The right to withdraw consent. You also have the right to withdraw your consent at any time where LSC LLC relied on your consent to process your personal information.

Please note that we may ask you to verify your identity before responding to any such requests. You have the right to complain to a Data Protection Authority about our collection and use of your Personal Data. For more information, please contact your local data protection authority in the EEA.

Children under Thirteen

LSC LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
